

MEMORANDUM OF UNDERSTANDING
BETWEEN

NATIONAL INSTITUTE OF DEVELOPMENT ADMINISTRATION
GRADUATE SCHOOL OF LANGUAGE AND COMMUNICATION
and

WALAILAK UNIVERSITY
SCHOOL OF LIBERAL ARTS

In order to encourage closer academic ties, National Institute of Development Administration by the Graduate School of Language and Communication located at 148 Seri-thai Rd., Klongchan, Bangkapi, Bangkok and the School of Liberal Arts at Walailak University located at 222 Thaiburi, Thasala District, Nakhonsithammarat entered into an agreement of cooperation to establish programs of exchange and collaboration in areas of interest and benefit to both institutions. This agreement will serve as a general framework for cooperation between the two institutions and is intended to facilitate discussions of more specific programs of collaboration. In particular, the two institutions agree:

- a. to support scholarship for lecturers and students wishing to pursue higher education; and
- b. to increase collaborations between both institutions, academic exchanges, research projects, publications, educational programs, and possible activities.

A designated person at each institution shall oversee and facilitate the implementation of this agreement in cooperation with other appropriate administrators at the respective institution.

The scope of activities under this agreement shall be determined by the funds regularly available at both institutions for the types of collaboration undertaken and by such other financial assistance as may be obtained by either institution.

The present Memorandum of Understanding goes into effect from the date of its signature by THE PARTIES and will remain valid for the period of five (5) years. Either institution wishing to terminate this Agreement shall notify the other institution in writing at least six (6) months prior to termination. Such notification shall not affect the status of the students that have already been accepted for programs initiated prior to the termination of this Agreement. Any decision to renew or renegotiate the terms of this Agreement shall be made on the basis of consultations and written consent between the two institutions.

**ADDENDUM A
TO THE
MEMORANDUM OF UNDERSTANDING

WALAILAK UNIVERSITY
SCHOOL OF LIBERAL ARTS**

On behalf of the National Institute of Development Administration by Graduate School of Language and Communication (hereinafter referred to as "NIDA GSLC"), and Walailak University by the School of Liberal Arts (hereinafter referred to as "WU SLA"), hereby incorporate this Addendum A to their Memorandum of Understanding (MOU): both documents to be signed simultaneously. For the purpose of forging closer academic ties and cooperation and exploring programs of exchange and collaboration in areas of interest and benefit to both institutions.

Areas of Collaboration

To collaborate and support activities between WU SLA and NIDA GSLC, the following is agreed to:

- 1) NIDA GSLC will support scholarships (types 2 and 3) for undergraduate students of WU SLA wishing to pursue higher education at NIDA GSLC. This depends upon the funding opportunity offered each academic year by National Institute of Development Administration and the grantees have to meet specific requirements of eligibility criteria of NIDA GSLC.
- 2) The collaboration expands to cover joint research projects depending on the agreement of the research area of interest and shared authorship on publication between NIDA GSLC and WU SLA.
- 3) The collaboration includes programs and activities arising from the invitation and agreement of the two institutions, NIDA GSLC and WU SLA. NIDA GSLC will contribute English language proficiency to support WU SLA in translation, presentation, and consultation to promote an international atmosphere. In turn, WU SLA will contribute the staff's expertise to support GSLC NIDA in academic activities if required.

The scope of activities under this Addendum shall be determined by the funds regularly available at both institutions for the types of collaboration undertaken and by such other financial assistance as may be obtained by either institution. Upon approval by each institution, this Addendum shall be in effect for a term of five (5) years. Thereafter, it may be renewed for an additional term upon the written consent of both Parties and upon such terms and conditions as agreed to by the institutions at the time of renewal. Either institution may terminate this Addendum at any time upon giving at least six (6) months prior written notice to the other institution. There shall be no penalty payment due upon the early termination of this Addendum.
