Application for Admission (Scholarships)

Master of Management Program in Integrated Tourism and Hospitality Management

(English Program), Regular Program (Full-time)

1st Semester, Academic Year 2026 (Round 1/2026)

The National Institute of Development Administration (NIDA) aims to encourage and support individuals with outstanding academic performance at Bachelor's Degree level to pursue their Master's Degree education (Regular Program). NIDA is granting three types of scholarships as followings:

1. Scholarship Type 1 Scholarship recipients shall be waived from tuition fees throughout the program of study monthly allowances and other educational support will also be provided throughout the program.
2. Scholarship Type 2 Scholarship recipients shall be waived from tuition fees throughout the program of study.
3. Scholarship Type 3 Scholarship recipients shall pay half of tuition fees throughout the program of study.

The Graduate School of Tourism Management, National Institute of Development Administration (NIDA) invites applications for admission to Master of Management program in Integrated Tourism and Hospitality Management (English Program) for 1st Semester, the academic year 2026. Five majors are available:

- Integrated Tourism and Hospitality, Policy, Planning and Management
- Integrated Tourism and Hospitality Management
- Hotel Management
- Airline and Transportation Management
- Hospitality Management

1. Applicant Qualifications

1.1 Students who enter into the program shall meet the following requirements in English proficiency, specified by NIDA:

- a. 500 points in TOEFL or higher,
- b. 5.5 points in IELTS or higher,
- c. Results of an English test by the Chinese government at level 6 or higher,
- d. Results of an English test by NIDA (NIDA TEAP) at level 500 or higher

e. NIDA TEAP or the Test of English Proficiency that conducted by standard organization or representative of the government from applicants' country. English test results must not exceed 2 years (1 year for NIDA TEAP) by the time the applicants submit the results to the institute or before first semester starts; or

f. Applicants are required to submit a test score of either 500 for TOEFL, 5.5 IELTS, 500 NIDA TEAP or the Test of English Proficiency that conducted by standard organization or

g. Representative of the government from applicants' country. English test results must not exceed 2 years (1 year for NIDA TEAP) by the time the applicants submit the results to the institute or

h. Proof of being an active NIDA student status and have studied in any program in English program or international program.

Remark: Applicants might get the permission to not provide evidence of English Proficiency depends on the consideration of program committee and shall approve by the Dean.

NIDA reserves the right to verify the applicants' qualifications at any time. Applications who do not have the required qualifications will not be admitted to the program. No refunds will be issued. If an applicant has already been accepted but is subsequently determined to be disqualified, student status will automatically be canceled.

NIDA reserves the right to cancel the enrollment of any programs which cannot meet the requirement regarding minimum number of student registration with no application fee refunds.

1.2 Qualification of application scholarship Type 1 must hold a Bachelor's Degree or the equivalent, or be currently studying in the last semester of a Bachelor's Degree program (Applicants must graduate before the beginning of the semester at NIDA). Applicants must have a minimum GPA of 3.00 in their Bachelor's Degree.

1.3 Qualification of application scholarship Type 2 must hold a Bachelor's Degree or the equivalent, or be currently studying in the last semester of a Bachelor's Degree program (Applicants must graduate before the beginning of the semester at NIDA). Applicants must have a minimum GPA of 2.75 in their Bachelor's Degree.

1.4 Qualification of application scholarship Type 3 must hold a Bachelor's Degree or the equivalent, or be currently studying in the last semester of a Bachelor's Degree program (Applicants must graduate before the beginning of the semester at NIDA). Applicants must have a minimum GPA of 2.50 in their Bachelor's Degree.

NIDA reserves the right to examine documents and eligibility of an applicant at any time. If the applicant is found ineligible after being admitted the announcement of acceptance shall be considered null and void.

The periods of validity of the test score are as follows:

- 1) NIDA TEAP score valid for 1 year.
- 2) English Test by the Chinese government Score valid for 2 years.
- 3) TOEFL and IELTS are valid for 2 years until the date of submission.

- 4) The Program duration is around four to five semesters depending on students study plan and mode of study. Minimally, students must register at least nine credits in each semester except summer semester.
- 5) Tuition fees may change according to any announcement by NIDA.

2. Online Application

Applicants can visit <https://admission.nida.ac.th> and must follow the following instructions :

- 1) Select the menu “**Login**”
- 2) Log in using an email address to receive an OTP (One-Time Password)
- 3) Select the menu “**Apply for Admission**”
- 4) Choose the program
- 5) Fill out profile information.
- 6) Upload all required application documents.
- 7) Submit the application.
- 8) Pay the application fee of **1,000 Baht** (Payment fee/charge Depends on rate of each payment method /transaction) via the following options:
 - Pay at any branches of Bangkok Bank Public Company Limited; or
 - Pay at any Counter Service (at 7Eleven stores); or
 - Pay via Internet/Mobile Banking
- 9) Applicants are required to attach evidence of payment to their application documents.

Notes:

- 1) Applicants can check their payment status, examination date, time and venue, as well as the admission results via the main menu at <https://admission.nida.ac.th>, according to the schedule specified in the admission announcement.
- 2) The paid application fee is non-refundable.
- 3) All required application documents must be uploaded only through the online admission system
- 4) The submitted documents will not be returned.
- 5) If applicants are unable to complete the documentation and payment process, the application will be considered invalid and the applicants will not be eligible for any examinations for admission.
- 6) The examination application is complete when the Institute verifies the application documents and payment made within the prescribed time. Applicants can check their application status two days after the payment has been made at <https://admission.nida.ac.th>

5. Required Documents

- 5.1 Completed application form
- 5.2 Bachelor's Degree diploma
- 5.3 Completed official transcript of undergraduate studies
- 5.4 1" x 1" photo taken not more than six months prior to the application date
(1 Photo)
- 5.5 A copy of identification card or passport (for non-Thai applicants)
- 5.6 A certificate of change of name or surname (if applicable)

Note: Applicants must submit all required documents before the interview date; otherwise, the application will be considered incomplete and will be voided. The student status will be automatically terminated, or subject to NIDA council's discretion.

For applicants who graduated from institutions outside Thailand, the following documents are required:

- 5.7 A Letter of Confirmation on Standard Curriculum for the Bachelor's Degree. This can be obtained from the Bureau of Standards and Evaluation at the Commission on Higher Education, Ministry of Education. (Contact the Educational Service Division for more information)

5.8 An Official Letter of Certification for their Bachelor's Degree with their University Council's approval as well as a complete transcript with the specified date of graduation which must be sent directly from the applicant's university to the address below:

Note: The documents mentioned in 5.7 and 5.8 , above, must be submitted before the start of the semester, Applicants who fail to submit all required documents will not be admitted to the program.

Applicants whose application documents are incomplete or misleading documentation, or who do not meet the required qualifications will not be considered for admission and in case the admission results are already announced, the application of the successful may be expelled at any time if found to be in violation of the above qualifications. Any fees paid are non-refundable

The program committee consider to call the qualified candidates for an interview with the faculty members of the Graduate School of Tourism Management. The committee will evaluate the applicants based on credentials, education background, and experiences.
